



GAIF's operating lease contracts continued to perform well during April 2017. Since inception in May 2013 GAIF has had an unbroken run of 48 consecutive positive monthly returns and has an annualised return of 8.522%. This compares favourably with the HxDA Other Fixed Income Strategies Index annualised returns of 2.704%. No losses were suffered by the GAIF portfolio of leases as a result of arrears or default during the month.

The Fund will also seek to invest in operating leases over assets used in energy efficiency projects to reduce greenhouse gas emissions. Lessees will typically be Australian federal, state or municipal governments, listed and unlisted corporate or long established businesses. GAIF does not finance consumer operating leases. Assets leased are generally of an essential business nature and the Fund's investments will, where possible, be further secured by guarantees and charges over leases and related assets granted by the lessees or security issuers.
